MINUTES 40th ANNUAL GENERAL BODY MEETING

HELD ON 28th September 2023 AT GMA Office, 408, Ansal's Saytyam Building, RDC, Raj Nagar Ghaziabad

The Governing Council, Executive Committee Members and the general members of the Association met at 11.00 AM at GMA office, Ghaziabad for the 40th General Body Meeting of the Association.

This was attended by about 25 persons. The following business was transacted:

Minutes of the 39thAnnual General Meeting held on 26th September 2022 at IMS Ghaziabad U C Campus were reviewed and approved.
